Dear Governor Hochul, Chair Christian, and Commissioners,

We write to you today as representatives of New Yorkers who are already facing the existing unaffordability of utilities, while Con Edison proposes an additional \$1.7 billion revenue increase for 2023. The company's proposal in the ongoing rate case will translate to an increase of \$20.90 more per month for electricity and \$37.88 more for gas for an average customer - over \$700 a year. For the median New York State household, the proposed increase translates to nearly a full percent of their income. For Con Edison, this proposal will translate to greater profits.

Working-class New Yorkers need another chance to be heard in the course of this ongoing rate case which will determine whether the state accepts ConEd's proposal to increase already high utility rates. The Public Service Commission must hold another public hearing, as soon as possible, before a final settlement is reached between the Public Service Commission and Con Edison. The last public hearings were held in March of 2022, when even fewer New Yorkers knew of a potential rate increase.

As of February of this year, over 1.3 million New Yorkers were behind on their utility bills, owing over \$1.7 billion, according to an analysis from The CITY. As other household costs increase, the state cannot allow Con Edison to increase revenues to line their pockets while New Yorkers forgo basic needs to pay their utility bills.

We have heard from across our districts about the impossible choices that families have had to make because of the utility bill increases they've seen from the 2019 rate case. In the event of these rate increases, many have told us that they are unsure if they can continue to afford living in our neighborhoods.

While Con Edison is able to pay attorneys and lobbyists to fight for their interests, our constituents—working New Yorkers—have not been given an adequate seat at the table. We call on you to hold a public hearing immediately to give our constituents the chance to weigh in on a decision that will impact their lives deeply.
